A traditional driving competition has been designed to preserve some of the more traditional elements of driving. All types of carriages are welcome, including antiques, and the theme will be a country drive. Singles are encouraged to have a groom/passenger; pairs and tandems are required to have one groom; multiples are required to have two grooms. VSE entries are permitted to have one groom for pairs, tandems and multiples. Passengers are encouraged.

Entries will be judged on presentation, a country drive with five drivers' tests, and a short obstacle course. We will be observing the guidelines of the Carriage Association of America. A copy is available at <http://www.caaonline.com/>

There will be two courses available; short 4 – 5 miles; long 10 – 12 miles. An award luncheon for all will follow. There will be limited stabling for out of town participants.

ALL DRIVERS MUST BE MEMBERS OF THE AIKEN DRIVING CLUB. MEMBERSHIPS WILL BE AVAILABLE THE DAY OF THE SHOW. Non-Resident Memberships are available for \$20 and provide insurance coverage. Entry fee includes lunch for two people; additional lunches may be purchased for \$10 per person.
